

Instructions for All India Quota candidates coming for counseling / Admission for the academic session 2022-23 (via www.aaccc.gov.in)

1. Before entry to the state of Meghalaya all allotted candidates have to comply with the prescribed rules and regulations issued by Govt. of Meghalaya on COVID-19 (Please check <http://meghalayaonline.gov.in/covid/testing.htm>).
2. COVID-19 vaccination certificate are to be produced as and when asked for by NEIAH authorities on entering the Institute's premises.
3. All allotted candidates have to submit allotment letter alongwith other related Original documents at the time of admission as per Information bulletin and counseling scheme and FAQ of <https://aaccc.gov.in/WebinfoUG/File/ViewFile?FileId=212&LangId=P> (point No. 24 Page No. 19 & 20)
4. All allotted candidates have to submit at the time of counseling the said Bond in the prescribed format (Annexure- III, IV, V & VI) duly notarized by competent authority, without which admission will be denied.
5. All allotted OBC candidates have to produce **latest OBC NCL** certificate.
6. Admission fee is to be submitted through Bank challan only (Bank Challan format will be provided by Institute).

In case he/she discontinues his/her studies at any time during the entire BAMS/BHMS course of the University on any ground, I (father/guardian) shall pay to NEIAH, Shillong a stipulated sum of Rs. 50000/- as DD (Rs. Fifty thousand only), if he/she leaves the course within one month from the date of admission and a sum of

Rs.300000/- (Rs. Three lakh only) if he/she leaves the course of studies after one month from the date of admission.
