# Prospectus 2020-21

(For NE State seats only)

#### About the Institute

North Eastern Institute of Ayurveda and Homoeopathy (NEIAH) is an Autonomous Institute under Ministry of AYUSH, Govt. of India located at Mawdiangdiang, Shillong, Meghalaya. The institute was established by the Ministry of AYUSH, Govt. of India with the aim of imparting Graduate, Post-graduate, Doctoral and Research Programme in Ayurveda and Homoeopathy and also to provide quality medical facilities and act as referral hospitals. At present, the Institute is running one College of Ayurveda & one College of Homoeopathy offering under graduate courses in BAMS (Bachelor of Ayurvedic Medicine & Surgery) and BHMS (Bachelor of Homoeopathic Medicine & Surgery).

Since the commencement of its academic programme in 2016-17, the Institute has admitted 426 students till date. The first batch of students will graduate by 2022. The Institute has successfully organized two National Seminars, one Regional Seminar cum Workshop, three CME for Medical officers, short-term training courses, and several webinars. Prominent scholars of Ayurveda, Homoeopathy, Yoga, and Research Field are timely invited for Guest Lectures for the benefit of students of the Institute.

The Institute is going to admit 63 candidates each for BAMS (Bachelor of Ayurvedic Medicine & Surgery) and BHMS (Bachelor of Homoeopathic Medicine & Surgery) courses for the academic session 2020-21. Out of 63 seats, 31 seats will be for All India Quota, 31 seats will be for Northeast States Quota and 1 seat is for Foreign National. All India Quota seats will be directly filled up by Ministry of AYUSH via centralized counseling, to be notified by the Ministry through its website. Foreign National seat will be filled up through Indian Council for Cultural Relations (ICCR).

Applications are hereby invited only for NE States Quota. Candidates who have qualified in NEET 2020 and desirous of taking admission in NEIAH under North East States Quota (except Assam) for the above mentioned courses may access the prescribed application form and other details from the website www.neiah.nic.in.

# How to Apply:

Duly filled in applications in prescribed format enclosing self-attested copies of NEET 2020 Admit Card with Mark Sheet, testimonials in support of age, PRC, educational qualification certificate, caste/community/Persons with disabilities (PWD) certificate issued by competent authority of Central/State Govt., two copies of recent passport size photographs along with application fee (Demand Draft) should reach the office of "THE DIRECTOR, NORTH EASTERN INSTITUTE OF AYURVEDA & HOMOEOPATHY (NEIAH), MAWDIANGDIANG, SHILLONG, MEGHALAYA – 793018" on or before 30.11.2020 The envelope containing application form should be super scribed as "APPLICATION FOR ADMISSION INTO BAMS/ BHMS COURSE" followed by name of State (NE STATE) and sent by Hand/Speed-Post only.

- 1. Application received after the closing date will not be considered. The Institute shall not be responsible for any postal delay/ lapse on the part of courier agency or any other reasons whatsoever.
- 2. Institute reserves the right to make any amendment or cancellation of this advertisement wholly or partially without assigning any reason thereof.
- **3.** No Nomination of candidates from any state govt. will be entertained; admission will be solely on merit on the basis of NEET Score.
- **4.** Admission to the said courses will be subject to production of physical and medical fitness certificate issued by a Competent Medical Board, constituted by Institute.
- 5. The candidate shall have to appear for counseling (Document Verification), if called for, at his/her own cost.
- **6.** The date for determining the age limit is **31st December**, **2020**.
- 7. During admission, a student with his/her parents/ guardians has to furnish a Bond on non-judicial stamp paper of Rs. 10/- for the payment of liquidated charges at Rs. 50,000/- or Rs. 3, 00,000/-, whichever is applicable, for non-completion of the course. (Annexure- III & Annexure- IV).
- **8.** During admission, a student with his/her parents/ guardians has to furnish a Bond on non-judicial stamp paper of Rs. 10/- for Anti-Ragging. (Annexure- V & Annexure- VI).
- 9. A student is also to submit all original Certificates at the time of admission, which shall be duly returned on completion of the course.
- **10.** 75% attendance as per NEHU rules is mandatory for the students to be eligible for appearing in annual examination.
- 11. Any corrigendum/ order regarding this advertisement will be issued and posted on the Institute's website (www.neiah.nic.in) only. Candidates are advised to remain in touch with the website for this purpose. No separate corrigendum etc. will be published in newspapers.
- **12.** Application fee is **non-refundable**.
- **13.** Canvassing in any form may lead to disqualification of the applicant.
- **14.** No TA/ DA is entitled to the candidates for appearing in counseling/ admission.
- 15. In respect of any matter related with admission procedure for the session 2020-21, decision of Director NEIAH will be final.

# Courses & Distribution of Seats:

The Institute conducts the 5½ years Degree Course in Ayurveda and Homoeopathy viz., Bachelor of Ayurvedic Medicine and Surgery (B.A.M.S.) & Bachelor of Homoeopathic Medicine and Surgery (B.H.M.S.) respectively. The courses are full time regular courses as per the regulation of respective Councils, approved by Govt. of India and Govt. of Meghalaya. Both the courses are affiliated to The North Eastern Hill University (NEHU), Shillong.

<sup>\*31 (</sup>Thirty One) seats under the All India Open *Quota* will be filled up based on NEET 2020 score. Admission for the same will be done by AYUSH via centralized counseling.

<sup>\*\*</sup> In respect of Meghalaya state, 9 (nine) seats each in both BAMS and BHMS will henceforth remain constant for all academic sessions. In respect of other North Eastern States (except Assam), 4 (four) nos. of seats in BAMS & BHMS will be allocated to 04 (four) states and 03 (three) nos. of seats will be allotted to 2 (two) states for the current academic session. Number of seats will henceforth be interchanged amongst the North Eastern states and between BAMS and BHMS alternatively in every academic session.

\*\*\* For the seats under Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim and Tripura, state-wise merit of the applicants would be drawn on the basis of NEET 2020 and admission granted as per Reservation Policy of Govt. of India for states..

\*\*\*\*If there is no candidate available under the seats allocated to any of the North Eastern states, seat will automatically move to Open Merit List of NE states which will drawn on the basis of NEET score.

# Method of Selection:

- 1. A combined merit list of all the candidates will be drawn on the basis of their performance in the **NEET 2020** (state-wise).
- 2. Inter-se merit: In the case of two or more candidates securing equal marks in the Entrance Examination their inter-se merit shall be determined from the marks of the Entrance Examination as follows:
  - a) Eliminating first Physics marks.
  - b) If there is still a tie, by eliminating Chemistry marks.
  - c) If there is still a tie, by eliminating Botany marks.
  - d) If the tie is still not broken, then a candidate senior in age to a candidate who is junior in age.
- 3. Selected candidates will have to attend counseling and medical examination at the Institute at their own cost on the notified date. At the time of Document Verification, candidates will have to attend in person and will have to produce the original Mark sheets of the qualifying examination and other original documents such as proof of age, Caste Certificate, Character Certificate etc.
- **4.** To fill the vacancies arising due to the failure of appearance by the selected candidates, sufficient number of candidates from the waiting list will also be called for counseling intimating their merit position in order. Such candidates will have to appear for the counseling on the notified date at their own risk and cost.
- **5.** Candidates who fail to attend counseling/medical examination on the notified date shall forfeit their claim for admission and placement in the waiting list.
- **6.** Result and other related notifications will be made available in the official website **www.neiah.nic.in** and the Notice Board of NEIAH, Shillong.

# Eligibility Criteria:

- 1. Nationality: Applicant must be a citizen of India.
- 2. The applicant should have studied and completed their course in the schools located in India in the preceding two years. (Not applicable for foreign students)
- 3. He/She has completed the age of 17 years as on 31st December of the year of his/her admission to the 1st year BAMS/BHMS course and maximum age limit will be 25 years as on 31st December of the year of his/her admission. SC/ST candidates will get relaxation of age as per GOI Rules.
- 4. The applicant should have passed the qualifying examinations in the manner mentioned below:
  - **a.** Candidate must have passed 10+2 with the subject comprising Physics, Chemistry, Biology (Botany and Zoology).
  - **b.** The applicant must have passed in the Subject of Physics, Chemistry, Biology (or Botany and Zoology) and English individually and must have obtained a minimum of 50% for General candidates and 45% for ST/SC category candidates.
  - **c.** For foreign nationals, ICCR will be requested to forward the applications to NEIAH for admission under the AYUSH Scholarship Scheme. NEIAH will examine the applications in terms of admission into the course.

#### Medical Examination:

The selected candidates shall have to undergo medical examination by a Medical Board set up by the Institute, consisting of faculty members of the Institute. If, in the assessment of Medical Board, a candidate is found medically unfit to be admitted to the course, he/she will be rejected and will not be admitted and the decision of the Board shall be final in this regard. In that case, in his/her place, the next student in the order of merit will be admitted.

# Date of Joining:

Admitted candidates must join classes by the date stipulated by the Institute for the year of admission. The admission of the candidate, who fails to join the classes by the stipulated date, shall automatically stand cancelled and such seats shall then be offered to the candidates on the waiting list in order of merit.

# Fees & Expenses:

All the selected candidates are required to pay the admission fee, course fees and other deposits, etc. as per rule in force only by **NEFT**.

- 11. Application without Caste certificate (if applicable), not older than 6 months (**OBC Non Creamy Layer Certificate from competent authority**).
