# Prospectus 2023-24

(For NE State seats only)

#### About the Institute

North Eastern Institute of Ayurveda and Homoeopathy (NEIAH) is an Autonomous Institute, under the Ministry of AYUSH, Govt. of India located at Mawdiangdiang, Shillong, Meghalaya. The Institute has been established by the Ministry of AYUSH, Govt. of India with the aim to impart Graduate, Post-graduate, Doctoral and Research Programme in Ayurveda and Homoeopathy and also provide quality medical facilities and act as referral hospitals. At present, the Institute is running one College of Ayurveda & one College of Homoeopathy offering undergraduate courses in BAMS (Bachelor of Ayurvedic Medicine Surgery) and BHMS (Bachelor of Homoeopathic Medicine & Surgery).

Since the commencement of its academic program in 2016-17, the Institute has admitted more than 600 students to date. The first batch of students graduated in 2022, and currently third batch is pursuing their internship. Among students of 1<sup>st</sup> batch 10 nos. of BAMS & BHMS students got PG in reputed Institute of India. The Institute has successfully organized National Seminars, Regional Seminar and CME's for Faculty & Medical officers, and several webinars, Prominent Scholars of Ayurveda, Homoeopathy, Yoga, and Research field are timely invited for Guest Lectures for the benefit of students of the Institute.

The Institute is going to admit <u>63</u> candidates each for BAMS (Bachelor of Ayurvedic Medicine Surgery) and BHMS (Bachelor of Homoeopathic Medicine & Surgery) courses for the academic session 2023-24. Out of 63 seats, 31 seats will be for All India Quota, 31 seats will be for North East States Quota and one seat is for Foreign National.

All India quota seats <u>for 31 Seats</u> will be directly filled by AYUSH via centralized counseling, to be notified by the Ministry through its website (<u>www.aaccc.gov.in</u>). Foreign National seat will be filled up through Indian Council for Cultural Relations (ICCR).

#### Applications hereby are invited only for NE quota seats for 31 Seats in each

**course.** Candidates who have qualified in NEET 2023, conducted on all India basis by NTA and desirous of taking admission in NEIAH under North East States Quota (except Assam) for the abovementioned courses may download the prescribed application form and other details from the website www.neiah.nic.in.

#### How to Apply:

Duly filled in applications in prescribed format enclosing **self-attested copies** of NEET 2023 Admit Card with mark sheet, testimonials in support of age, PRC, educational qualification certificate, caste/community/Persons with disabilities (PWD) certificate issued by the competent authority of Central/State Govt., recent passport size photographs along with application fee (**Demand Draft**) should reach the office of "THE DIRECTOR, NORTH EASTERN INSTITUTE OF AYURVEDA & HOMOEOPATHY (NEIAH), MAWDIANGDIANG, SHILLONG, MEGHALAYA – 793018" on or before <u>03.10.2023</u> The envelope containing application form should be superscribed as "APPLICATION FOR ADMISSION INTO BAMS/BHMS COURSE" followed by name of State (NE STATE) and sent by **Speed-Post / by hand.**

- 1. Application received after the closing date will not be considered. The Institute shall not be responsible for any postal delay/ lapse on the part of the post agency or any other reasons whatsoever. The decision of the Director, NEIAH will be final in this regard.
- **2.** Institute reserves the right to make any amendment or cancellation of this advertisement wholly or partially without assigning any reason thereof.
- **3. No Nomination** of candidates from any State Health Directorate will be entertained; admission will be solely on merit list generated on basis of NEET Score.
- **4.** The admission to the said courses will be subject to the production of a physical and medical fitness certificate issued by a Competent Medical Board, constituted by the Institute.
- 5. The candidate shall have to appear for counseling (Document Verification), if called for, at his/her own cost.
- **6.** The date for determining the age limit is  $31^{st}$  December 2023.
- 7. During admission, a student with his/her parents/ guardians has to furnish a Bond on a non-judicial stamp paper of Rs. 10/- for the payment of liquidated charges at Rs. 50,000/- or Rs. 3, 00,000/-, whichever is applicable, for non-completion of the course. (Annexure-III & Annexure-IV).
- 8. During admission, a student with his/her parents/ guardians has to furnish a Bond on a non-judicial stamp paper of Rs. 10/- for Anti Ragging Bond. (Annexure- V & Annexure- VI).
- 9. A student has also to submit all original certificates at the time of admission, which shall be duly returned on completion of the course.
- **10.** 75% attendance as per NEHU / respective Council rules is mandatory for the students to be eligible for appearing in the annual examination.
- 11. Any corrigendum/ order regarding this advertisement will be issued and posted on the Institute's website (www.neiah.nic.in) only. Candidates are advised to remain in touch with the website for this purpose. No separate corrigendum etc. will be published in newspapers.
- **12.** The application fee is **non refundable**.
- **13.** Canvassing in any form may lead to the disqualification of the applicant.
- 14. No TA/DA will be entitled to the candidates for appearing in counseling/ admission.
- 15. In respect, if any matter related to admission procedure for the session 2023-24, the decision of the Director NEIAH will be final.

#### Courses & Distribution of Seats:

The Institute conducts the 5½ years (including one year internship) Degree Course in Ayurveda and Homoeopathy viz., Bachelor of Ayurvedic Medicine and Surgery (B.A.M.S.) & Bachelor of Homoeopathic Medicine and Surgery (B.H.M.S.) respectively. The courses are full-time regular courses as per the regulation of respective Councils, approved by Govt. of India and Govt. of Meghalaya. Both the courses are affiliated with the North-Eastern Hill University (NEHU), Shillong.

<sup>\*\*</sup> In respect of Meghalaya State 9 (nine) nos. of seats both BAMS and BHMS will henceforth remain constant for all academic sessions. In respect of other North-Eastern states (Except Assam), 4 (four) nos. of seats in BAMS & BHMS will be allocated to 04 (four) states and 03 (three) nos. of seats will be allotted to 2 (two) states for the present academic session. The number of seats will change amongst the North-Eastern states as per Institute roaster.

<sup>\*\*\*</sup> For the seats under Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim, and Tripura, the State-wise merit of the applicants would also be drawn based on marks obtained in NEET 2023 and admission granted as per reservation policy of the Institute.

\*\*\*\*If there is no candidate available under the seats allocated to any of the North-Eastern state Quota mentioned above, the seat will be converted to other NE states within remaining North-Eastern states as per the decision of Director, NEIAH.

# Method of Selection:

- 1. A combined State-wise & category-wise merit list of all the candidates will be drawn based on their performance in the **NEET 2023**.
- **2.** Inter-se merit: In the case of two or more candidates securing equal marks in the Entrance Examination their inter-se merit shall be determined as per All India Rank in NEET -2023.
- 3. Selected candidates will have to attend counseling (documents verification) and medical examination at the Institute at their own cost on the notified date. At the time of Document Verification, candidates will have to attend in person and will have to produce the original Mark sheets of the qualifying examination and other original documents such as proof of age, Caste Certificate, PRC, Character Certificate, etc.
- **4.** To fill the vacancies arising due to the failure of appearance by the selected candidates, a sufficient number of candidates from the waiting list will also be called for counseling intimating their merit position in the order. Such candidates will have to appear for the counseling on the notified date at their own risk and cost.
- **5.** Candidates who fail to attend counseling/medical examination on the notified date shall forfeit their claim for admission and placement in the waiting list.
- **6.** Result and other related notifications will be placed on the official website **www.neiah.nic.in** and the Notice Board of NEIAH, Shillong.

Eligibility Criteria: As per NEET-2023 guidelines and respective council's rules.

#### Medical Examination:

The selected candidates shall have to undergo a medical examination by a Medical Board set up by the Institute, consisting of consultants of the Institute. If in the assessment of the Medical Board, a candidate is found medically unfit to be admitted to the course, he/she will be rejected and will not be admitted and the decision of the Board shall be final in this regard. In that case, in his/her place, the next student in the order of merit will be admitted.

# Date of Joining:

Admitted candidates must join classes by the date stipulated by the Institute for the year of admission. The admission of the candidate, who fails to join the classes by the stipulated date, shall automatically stand cancelled and such seats shall then be offered to the candidates on the waiting list in order of merit.

# Fees & Expenses:

All the selected candidates are required to pay the admission fee, course fees, and other deposits, etc. as per the rule in force only by **Challan/Online.**
