#### <u>TENDER DOCUMENT</u> <u>Terms and conditions</u>

1. The bid documents for the above items should be addressed to **"The Director, North Eastern Institute of Ayurveda & Homoeopathy, Shillong, Mawdiangdiang-793018** and should only on or before the due date.

2. Earnest Money Deposit (EMD) for Rs.22,388/- (Rupees Twenty Two thousand three hundred and eighty eight) only, in the form of Bank Draft payable to the Director, North Eastern Institute of Ayurveda & Homoeopathic, Shillong in a separate Cover (C) superscribed "EMD Deposit".

**3. Tender Fee of Rs.1,000.00 (Rupees One thousand) only**, will be charged. The Fee in the form of Bank Draft in favour of Director, North Eastern Institute of Ayurveda & Homoeopathy (NEIAH), Shillong should be enclosed in a separate Cover along with the Technical Bid. "Tender Fee" may be neatly written on the Cover.

**4.** The successful Tenderer will have to submit **Performance Security Deposit equivalent to 3%** of the bid value. The Amount will be payable through Bank Draft/Bank Guarantee/Fixed Deposit Receipt drawn in favour of Director, North Eastern Institute of Ayurveda & Homoeopathy, Shillong. The validity of the Bank Draft will be up to 60 days after the period of Contract.

- **a.** The EMD shall not bear any interest and will be refunded to
- i. successful tenderer on receipt of Agreement and Bank Guarantee.
- ii. unsuccessful tenderer upon finalization of tender bid and award of tender to successful bidder.
- iii. all the tenderers if the tendered item is cancelled or retendered.
- iv. Tender fee is non refundable.

Note: EMD amount as mentioned above should be mandatorily be quoted against the quoted item. Technical bid should comprise of documents should be self attested, stamped and better quality – preferably.

#### 3. Trading License

a) The Bidders have to submit valid Trading License issued from the KHADC (Khasi Hills Autonomous District Council) or any other relevant document for exemption.

b) In compliance to the Govt. of Meghalaya letter No.DCA.36/91/323 dated: 24.06.2022. Non-Tribal Bidders has to furnish trading license issued from the KHADC (Khasi Hills Autonomous District Council) failing which the bid may be rejected. In case of non submission of the trading license from the non-tribal traders an undertaking for submission of the trading license is to be submitted along with the bid documents stating that if becomes a successful bidder should furnish the trading license within 07 (seven) days before any work order is issued failing which the bid will be rejected.

c. The Bidders should have a local office/service center in the city of Shillong.

d. Brochure or Catalogue with images of the product or Data sheet (if applicable) of the quipment and

accessories.

e. Technical Compliance Statement.

f. Proprietary certificate from the manufacturer mentioning the unique technology or feature/s mentioned apart from the brand name (If applicable).

g. If applicable Pre requirements required at the site of installation / use (Before submitting the bid, the tenderer should make pre-visit to the installation site and indicate the requirement along with the price bid wherever necessary)

h.Certificates for the equipment and accessories quality (If applicable such as ISO, FDA, CE etc.)

i. Delivery Period for supplying the equipment and accessories and if applicable time required for installation from the date of purchase order has to be indicated.

j. Copy of GST, PAN, TIN document.

k. Turnover for the last 3 Financial Year duly certified by the CA.

1. Solvency certificate issued from the bank or CA certified.

m. The Main Envelop containing the Technical Bid (Cover-A), Financial Bid (Cover-B) and Earnest Money Deposit (Cover-C) must be superscribed 'Tender for Providing Services/ Manpower to North Eastern Institute of Ayurveda & Homoeopathy'. The Quotations should be dropped in the Tender Box placed at Administrative Block of the Institute by the stipulated Date and Time. Tenders received after the last date and time or in any other manner, including Speed Post/Ordinary/Registered Post/Courier will not be accepted.

#### 3. Financial Bid should comprise of-

Quotation should be Price inclusive of equipment and accessories basic cost, each article wise or spares rates, taxes, other Government levies, Customs duty, installation and commissioning etc with a detailed break up mentioning manufacturers name, License number and name of the brand or make. The cost of logistics, transportation, delivery of the equipment and accessories to the Institute premises may be quoted sperately.Tender bids without price bid or quotation will be rejected.

4. Successful tenderer decision will be made on the basis of total cost of the equipment and accessories. All pages of the bid submitted must be signed along with seal and sequentially numbered by the tenderer.

5. The cost of the equipment & accessories (All item wise) mentioned in the tender will be freezed for one Year from the date of purchase order; however Institute reserves the right to procure or reject the purchase of Item wise equipment & Item wise Accessories with the successful tenderer on repeat order basis within 1 year from the date of purchase order.

#### 6. Evaluation of Bids:-

The technical bid of the tenderer will be evaluated to determine whether

- a. They are complete with respect to specifications.
- **b.** The requisite documents have been submitted and properly signed.

#### 7. Tender Opening:

a. The Financial bid of the technically qualified tenderers only will be opened.

**8.** Equipment and accessories should be:

**a.** covered with minimum 2 years warranty period for Group 1 (i.e. PanchakarmaEquipment & Accessories with 2 years warranty)

**b.** without warranty / default warranty period for Group 2 (i.e. Panchakarma Equipment & Accessories without warranty / default warranty) for normal or regular wear & tear from the date of supply / complete installation (Ready to use inall respects).

- **9.** If required, the tenderer should demonstrate the quoted model of the equipment and accessories at the institute during the technical evaluation, failing which their bid or offer shall be rejected. The tenderer will be intimated that they should get ready for demonstration. No request for extending time for demonstration will be entertained. Failure to demonstrate, their offer will be rejected.
- **10.** The tenderer should supply instruction manual of the tendered equipment and accessories at the time of supply.
- **11.** Necessary training / instructions on operation of the equipment and accessories should be given by the tenderer firm to NEIAH technical staff/s at free of cost after completion of the supply /Installation.
- 12. The successful tenderer should immediately submit an acceptance letter duly signed and sealed for the rate/s and offers agreed by both the parties to the Head of the Institution within reasonable time on receipt of the Purchase Order. The successful tenderer should also furnish a Bank guarantee only from a Nationalized bank to the extent of 3% of the total purchase order value, valid for 14 months the completion of the warranty period (irrespective of varying warranty for different equipment and accessories, the upper boundwarranty mentioned for any of the equipment and accessories will be considered for Bank Guarantee).

**13.** In the event of the successful tenderer failed to supply the item/execute the agreement/submit the Bank Guarantee the EMD deposited by them shall stands forfeited.

#### 14. Payment terms:

Payment will be made only after good working condition of the equipment and accessories certified by the end user. NO ADVANCE PAYMENT WILL BE ENTERTAINED.

- **15.** Any corrections/changes in the tender will be uploaded as corrigendum in the NEIAH website only.
- **16.** If the tender last/opening date falls on any general/government/institute holiday(s), then the successive dates will be postponed by equivalent days of holiday(s), however the time remains unchanged.
- **17.** The Director reserves the right of ordering/not ordering/cancelling/increase or decrease the quantity and to reject any or all tender quotations without assigning any reason. The decision of the Director, NEIAH, Shillong, shall be final in all the controversies that may arise in the matter.
- **18.** Any dispute arising out of this will be subject to the jurisdiction of the Court in Shillong.
- **19.** Failure to adhere any of the above terms and conditions the bid(s) may be rejected and EMD maybe forfeited.
- **20.** None of the terms and conditions of the supplier shall be applicable to the purchase contemplatedhere under, irrespective of it being attached to any documents to be provided to NEIAH. Such exercise shall have no meaning and binding effect unless the same is accepted by NEIAH in writing.
