1st Batch

### About the Institute

North Eastern Institute of Ayurveda and Homoeopathy (NEIAH) is an Autonomous Institute, under the Ministry of AYUSH, Govt. of India located at Mawdiangdiang, Shillong, Meghalaya. The Institute has been established by the Ministry of AYUSH, Govt. of India with the aim to impart Graduate, Post-graduate, Doctoral and Research Programme in Ayurveda and Homoeopathy and also provide quality medical facilities and act as referral hospitals. At present, the Institute is running one College of Ayurveda & one College of Homoeopathy offering undergraduate courses in BAMS (Bachelor of Ayurvedic Medicine Surgery) and BHMS (Bachelor of Homoeopathic Medicine & Surgery). The Institute has started Post Graduation (PG) Course in Homoeopathy from 2023-24 academic session in 04 subjects with 02 seats each in Homoeopathic Philosophy, Homoeopathic Materia Medica, Repertory & Practice of Medicine. NEIAH is the pioneer Institute to offer PG in Homoeopathy in the entire North Eastern Region of India.

Since the commencement of its academic program in 2016-17, the Institute has admitted more than 700 students to date. The first batch of students graduated in 2022, and currently third batch is pursuing their internship. Among students many of BAMS & BHMS students got PG in reputed Institutes of India. The Institute has successfully organized National Seminars, Regional Seminar and CME's for Faculty & Medical officers, and several webinars, Prominent Scholars of Ayurveda, Homoeopathy, Yoga, and Research field are timely invited for Guest Lectures for the benefit of students of the Institute.

North Eastern Institute of Ayurveda and Homeopathy (NEIAH) is going to admit **08** Post-Graduate (Homeopathy) candidates for 04 subjects with 02 seats each in Homoeopathic Philosophy, Homoeopathic Materia Medica, Repertory, and Practice of Medicine for the academic session 2023-24. Out of 08 seats, **04 seats are for All India Quota and 04 seats are for Open North East Category seats**, of which 02 seats are reserved for students who graduated in BHMS from NEIAH and 02 seats are reserved for students having North Eastern PRC only.

All India quota for 04 Seats will be directly filled by AACCC thorugh centralized counseling, to be notified by AACCC in its website (www.aaccc.gov.in).

Applications are hereby invited only for Open North East Category in 04 seats. Candidates who have qualified in AIAPGET- 2023, conducted on All India basis by NTA and desirous of taking admission at NEIAH under the Open North East category seats for the abovementioned programme may download the application form and other details from the website www.neiah.nic.in.

### About MD (Hom) Course:

M.D. (Hom) degree course is a full-time regular residential course of three years' duration. The course curriculum is as per the regulations of the National Commission of Homoeopathy (NCH). The total no. of seats for M.D. (Hom) degree course at NEIAH, Shillong is 08. As per NCH permission letter for admission in the academic session 2023-24, vide letter no. F. No. 4-7/2022-23/NCH (MA&RBH)(125-O1)/2696; dated 27<sup>th</sup> September, 2023 the details of the subject & number of PG seats are as follows:

#### Note -

- > 50% of the total seats are "All India quota seats" will be directly filled by AACCC via centralized counseling, to be notified by the Ministry through its website (www.aaccc.gov.in).
- ➤ The Remaining 50% of the seats are "Open Northeast Category" of which 50% [i.e. 25% of overall seats] are reserved for BHMS graduates from NEIAH, Shillong irrespective of PRC and remaining 50% (i.e. 25% of overall seats) are reserved for the students having North Eastern PRC only.
- > Selection will be entirely on the basis of Merit of the candidates applied for "Open North East Category" seats on the marks secured in AIAPGET-23. Candidates who have qualified in AIAPGET- 2023, conducted on All India basis by NTA and desirous of taking admission at NEIAH under the Open North East category seats for the abovementioned programme.
- > Rotation of Open North East Category seats will be as per Institute roster.

# Eligibility Criteria:

- 1. **Nationality**: Applicant must be a Resident Indian National.
- 2. (a) **Permanent Resident/Domicile** of one of the 8 (eight) North-eastern states of India including Sikkim to be eligible for North East PRC seats only..

- (b) **Graduates of NEIAH** (**irrespective of domicile status**) to be eligible for admission in to the seats reserved for the students passing BHMS from NEIAH, Shillong.
- (c) **Educational:** The candidates must possess BHMS Degree recognized by National Commission for Homoeopathy (NCH) in the Second Schedule of Homoeopathy Central Council Act, 1973 and must have completed the compulsory Rotating one year Internship training on or before 31<sup>st</sup> October, 2023.
- (d) Every student, selected for admission to Post Graduate course shall possess valid Registration Certificate from the Board of Homoeopathic Medicine, Meghalaya or National Commission for Homoeopathy (NCH). Candidates who are not registered with the Board of Homoeopathic Medicine, Meghalaya or National Commission for Homoeopathy (NCH) shall have to obtain Registration with the Board of Homoeopathic Medicine, or National Commission for Homoeopathy (NCH) within one month of admission to the PG course.
- (e) The candidates who have already done/are pursuing MD (Hom) degree in any subject in any University at the time of counseling shall not be considered for admission to MD (Hom) courses at NEIAH. If it is found at a later stage that the candidate has given false undertaking at the time of counseling, his/her candidature/registration shall be cancelled forthwith.

- 3. Candidates wishing to apply for both categories has to submit separate application form along with relevant documents and application fees.
- 4. Duly filled up application forms alongwith all relevant documents and fee receipts has to be submitted through email to <a href="mailto:neiahadmission@gmail.com">neiahadmission@gmail.com</a> in a single PDF mentioning subject "Application form Open NE category seats" on or before 28<sup>th</sup> November, 2023 upto 12:00 hour.
- 5. It will be the responsibility of the candidate to ensure that correct address, email address and mobile number is entered in the Application Form.

6. Candidates not belonging to the 8 (eight) North Eastern States (i.e. without PRC from these states) or candidate who is not a student of NEIAH need not apply for the Open North East Category seats. If any such candidate applied for Open North East Category seats is at her/her own risk. Candidature of such candidate will be rejected and his /her name will not appear in the merit list.

- 4. Admission of candidates to the MD (Hom) is provisional, subject to their being eligible for admission to PG courses.
- 5. If ineligibility of a candidate is detected at any stage, before or after his /her admission, his/ her admission will be summarily rejected and candidate in the merit next to him/her will admitted accordingly.
- **6.** Institute reserves the right to make any amendment or cancellation of this advertisement wholly or partially without assigning any reason thereof.
- **7. No Nomination** of candidates from any State Health Directorate will be entertained; admission will be solely on merit list generated on basis of AIAPGET-2023 Score.
- **8.** The admission to the said courses will be subject to the production of a physical and medical fitness certificate issued by a Competent Medical Board, constituted by the Institute.
- **9.** The candidate shall have to appear for counseling (Document Verification), if called for, at his/her own cost.

- 10. During admission, a student with his/her parents/ guardians has to furnish a Bond on a non-judicial stamp paper of Rs. 100/- for the payment of liquidated charges at Rs. 1,00,000/- for non-completion of the course. (Annexure-III).
- 11. During admission, a student with his/her parents/ guardians has to furnish a Bond on a non-judicial stamp paper of Rs. 10/- for Anti Ragging Bond. (Annexure- V & Annexure- VI).
- 12. A student has also to submit all original certificates at the time of admission, which shall be duly returned on completion of the course.
- **13.** 75% attendance as per affiliating university / respective Council rules is mandatory for the students to be eligible for appearing in the annual examination.
- 14. Any corrigendum/ order regarding this advertisement will be issued and posted on the Institute's website (www.neiah.nic.in) only. Candidates are advised to remain in touch with the website for this purpose. No separate corrigendum etc. will be published in newspapers.
- 15. The application fee is non refundable.
- **16.** Canvassing in any form may lead to the disqualification of the applicant.
- 17. No TA/ DA will be entitled to the candidates for appearing in counseling/ admission.
- 18. In respect, if any matter related to admission procedure for the session 2023-24, the decision of the Director NEIAH will be final.

## Submission of documents for counseling:

- 1. The candidates applying for NE PRC seats must submit a Permanent Residential Certificate valid for the year 2023, from the competent authority (i.e. District Commissioner of the state or any Government authorized Official) proving that he/she is Permanent resident of one of the 8 (eight) North Eastern states of India including Sikkim.
- 2. No Objection Certificate: In case the candidate joined elsewhere in PG course have to bring NOC from the concerned college for joining the PG course in NEIAH.
- 3. Candidates who are employed may also register and apply and submit their applications. However, a "NO OBJECTION CERTIFICATE" (NOC) from competent authority must be submitted alongwith application.
- 4. Candidates have to submit the following documents at the time of submission of application

### Method of Selection:

- Merit list of all the candidates will be drawn based on AIAPGET-2023 score/rank conducted by NTA. Accordingly, candidates will be called for counselling in order of merit and can exercise their respective choice of subject according to merit and availability of seats. In case of absentee, the next candidate in merit will be considered. The subject choice will be given on the basis of merit.
- 2. For North Eastern PRC seats, a merit list will be prepared from the candidates having PRC of any of 8 North Eastern States viz. Assam, Meghalaya, Manipur, Tripura, Mizoram, Nagaland, Arunachal Pradesh and Sikkim. Another merit list will be prepared for the candidates who have passed out BHMS from NEIAH irrespective of their status of domicile/PRC.
- 3. Inter-se merit: In the case of two or more candidates securing equal marks in the Entrance Examination their inter-se merit shall be determined as per All India Rank in AIAPGET 2023.
- 4. Shortlisted candidates will have to attend counseling (documents verification) and medical examination at the Institute at their own cost on the notified date. At the time of Document Verification, candidates will have to attend in person and will have to produce the original Mark sheets of the qualifying examination and other original documents such as proof of age, Caste Certificate, PRC, etc.
- 5. No candidate will be allowed to attend the counseling without original certificates as mentioned above.
- 6. Any candidate (Indian citizen) who has taken admission elsewhere or employed in India or abroad and deposited their original certificate in their respective college will be allowed to attend the first Counselling at NEIAH subject to the condition that he/she provides NOC from the said College/Institution. A seat purely on provisional basis will be offered depending upon the availability of a seat at his / her rank. They have to submit their original documents within 5 days from date of counseling/admission, failing which his/her seat will stands automatically cancelled.
- 7. To fill the vacancies arising due to the failure of appearance by the selected candidates, a sufficient number of candidates from the waiting list will also be called for counseling intimating their merit position in the order. Such candidates will have to appear for the counseling on the notified date at their own risk and cost.
- 8. Candidates who fail to attend counseling/medical examination on the notified date or who decline the available seats for allotment or those who will not join the allotted seat on the date of admission shall forfeit their claim for the seat.
- 9. Candidates, who have been admitted, must join the concerned department within the date mentioned in the Seat Allocation letter/admission letter. If they do not join within the

- stipulated time, they shall forfeit all their claims for a seat and fees deposited will not be refunded.
- 10. In case of any dispute arising out of the allocation of a seat at the time of the counselling, the decision of the Director, NEIAH will be final.
- 11. All disputes pertaining to the allocation of seats in various subjects by counselling will be subject to the **jurisdiction in the Meghalaya High Court**, **Shillong Meghalaya**.
- 12. Result and other related notifications will be placed on the official website **www.neiah.nic.in** and the Notice Board of NEIAH, Shillong.

### Terms & Conditions for admission:

- Admission to MD (Hom) Degree Course at NEIAH, Shillong is subject to acceptance of Rules and Regulations of the Institute or which will be implemented by the competent authority from time to time.
- 2. Admission is Provisional subject to verification of documents and fulfilling the eligibility criteria
- 3. The candidates are required to submit all the relevant documents (certificates, mark sheet etc.) in original to NEIAH, Shillong at the time of admission. The **original certificates submitted shall not be returned to the candidates till the course is completed**. If any candidate requires to withdraw Original documents for any reason, he/she needs to deposit a Compensatory Bond amount in shape of Demand Draft of Rs.1,00,000/- (One Lac Only) drawn in favour of "Director, North Eastern Institute of Ayurveda and Homoeopathy, Shillong", payable at Shillong and post-dated cheques in the name of "Director, North Eastern Institute of Ayurveda and Homoeopathy, Shillong", amounting to the total amount of stipend received till the date of withdrawal of original certificates. If he/she does not discontinue the course and returns all the original documents (certificates, mark sheet etc.) back to NEIAH, then the draft & the cheques will be given back to the concerned PGT.
- 4. Candidates selected to the MD (Hom.) Degree courses at NEIAH, Shillong shall be full time regular trainee. Service holders will have to apply for study leave and are required to produce the orders from the competent authority wherein such leave has been sanctioned to them, within 01 (one) months of joining to the course.
- 5. Candidates who have already completed MD (Hom.) Degree Course on previous occasion in any University are not eligible for taking admission to the course.
- 6. The selected candidates shall have to undergo a medical examination by a Medical Board set up by the Institute, consisting of consultants of the Institute. If in the assessment of the Medical Board, a candidate is found medically unfit to be admitted to the course, he/she will

be rejected and will not be admitted and the decision of the Board shall be final in this regard. In that case, in his/her place, the next student in the order of merit will be admitted.

## Fees & Expenses:

All the selected candidates are required to pay the admission fee, course fees, and other deposits, etc. as per the rule in force only by **Online mode.**

### Date of Joining:

Candidates, who have been admitted, must join the concerned department within the date mentioned in the Seat Allocation letter/admission letter. If they do not join within the stipulated time, they shall forfeit all their claims for a seat and fees deposited will not be refunded.

### Guides for MD (Hom):

NCH approved list of Examiners /Guides as communicated by North Eastern Hill University (NEHU), Shillong to this institute from time to time shall act as Guide/Examiner for the M.D.(Hom) Examinations.

### Stipend:

- 1. Aadhaar Card/Number of the PGTs is mandatory for disbursement of Stipend through DBTS.
- 2. Stipend may be paid by the Institute as per the order from Ministry of Ayush, Govt. of India from time to time.
- 3. Stipend will be released for those Post Graduate Trainees (PGTs) who are regular in attendance and show good progress every month in their academic and clinical pursuit. In-Service Candidates shall not be paid with stipend if they draw leave salary or salary from the office of their appointing authority.
- 4. The stipend is payable after verification of attendance, overall performance and on recommendation of satisfactory progress by the Head of the Department and Principal/Hospital authority.
- 5. Students are discouraged from discontinuing the course at any time after the commencement of the same. Every PGT on admission must execute a bond (Notarized) on non-judicial stamp paper of ₹100/ in the form specified in Annexure-III; abiding to study and complete the course and that in case he/she fails or leaves the course or if his /her admission is cancelled by the Institute before completion for any reason, he/she shall have to pay ₹1,00,000/- (Rupees One Lakh only) and return the total amount of stipend received by him /her from the Institute till date.

# Institute Rules & Regulations:

1. All powers relating to discipline and disciplinary action are vested in the Director.

- 2. The Director may delegate all such powers, as he/she deems proper to the Principal, College of Homoeopathy, Deputy Medical Superintendant, Homoeopathy Hospital and to such other persons as he/she may specify on his/her behalf.
- 3. Candidates are required to follow the rules and regulations of the Institute by word and spirit and should abide by the regulations of the University.
- 4. This Institute shall not entertain application/representation/letter signed collectively addressed to the authority. No correspondences/communication in the way of letters /complaints individually or collectively shall be sent to the higher authority directly without proper prior permission of HOD/ competent authority.
- 5. He/She shall not meet collectively/individually any political person(s)/give interview to any media or invite any media personnel to the Institute premises without the proper prior knowledge of the Director/Institute Authority.
- 6. They should obey the instructions of Principal, College of Homoeopathy, Deputy Medical Superintendant, Homoeopathy Hospital, other faculty members during their training along with instruction of their respective HODs and other Departmental In-charges.
- 7. All students shall comply with the Rules, Regulations and general discipline of the Institute, which will be implemented by the competent authority from time to time. Any student(s) infringing with the rule & regulation of the Institute shall be dealt with appropriate disciplinary/legal action as decided by Director, NEIAH including expulsion of the student (s) from the Institute without any further notice or any compensation in lieu thereof.
- 8. The period of training of Doctor of Medicine in Homoeopathy [MD (Hom)] shall be of three years (full time) duration in the department concerned.

### Attendance and Leave:

Students are not allowed to remain absent without prior permission of the competent authority (except under special circumstances as per discretion of competent authority). Leave without prior permission will be treated as unauthorized leave and this will attract disciplinary action. Students are required to secure minimum percentage of attendance as prescribed by the NCH as well as by the affiliating University to be allowed to appear for examination. Strict adherence to the biomatric policy for attendance is binding on all students. Strict adherence to the rules of signing the daily attendance both in academic section and hospital section is must. Anybody found violating the rules or doing any malpractice shall be dealt with appropriate administrative action as may be decided by the authority. All candidates must be punctual in attending academic activities and clinical duties as assigned by the Institute authority.

Availing the leave cannot be treated as matter of right. Leave entitlement & Leave rule of PG trainees will be notified later.

# Cancellation of Studentship:

The Director NEIAH, Shillong may at any time before completion of the Postgraduate course either by his/her own motion or on receipt of complaint from any person, after due and proper

enquiry and after giving the person one-week time from the date of the receipt of the show cause notice to submit written explanation and/or a personal hearing, order the cancellation of admission to Postgraduate course. If in the opinion of the Director, any candidate had furnished false, fabricated/tampered documents or incorrect information and/or is found to have concealed/suppressed or withheld any information at the time of admission to this Institute or on later dates shall be dealt with as per law. Practice of unfair means during continuing the training would lead to serious consequences including legal proceedings.

If the Director/ HOD understands that the candidate is involved in any activity that affects the image/reputation of the Institute or any misconduct with faculties/seniors/staff/patients and/or putting signature for someone other than himself/herself in the attendance register or arranging someone to put signature on behalf of himself/herself in his/her absence in the attendance register in hospital or in the department, appropriate administrative and legal action will be initiated against the candidate. At the same time tampering of any official documents shall attract the same penalty. Any other action that may be considered appropriate by the Director of the Institute shall also be taken against him/her, which may include civil/criminal prosecution as appropriate to the case. The admission shall be automatically cancelled without any notice or any compensation in lieu thereof, irrespective of the stage at which the error is discovered. Any student either individually or collectively if found indulging in any activity which affects the normal administrative/ academic or patient care activities shall be liable for cancellation of studentship.

# Discipline and duties:

All students shall comply with the Rules, Regulations and general discipline of the Institute, which will be implemented by the competent authority from time to time. Detailed instructions and duties will be notified later.

#### Hostel/Accommodation:

The accommodation facility is currently available only for female candidates on twin sharing basis. Allotment of seats shall be made only on availability basis. Every candidate seeking admission to the Institute hostel shall make an application in duplicate during admission in the prescribed application form available with the Hostel In-charge along with hostel fee receipt. Hostel Fee has to be deposited separately at the time of admission (on digital mode).

No claim for single room or preference for room or roommate shall be considered.

All out-station candidates, at the time of admission shall furnish particulars [name/address/contact telephone number(s)] of their local guardians to whom Institute shall

contact in case of emergency or otherwise intimation could be sent whenever the parents/legal guardian could not be contacted. The local guardian must be a responsible person; he/she shall not be any student who is pursuing his/her studies in this Institute or in any other Institute.

Family /Guest/visitors shall not be allowed to stay within the hostel premises.

Note: Institute shall bear no responsibility for arranging any type of accommodation for any male students or providing subsidy on hostel/ accommodation fees from the Ministry. Kindly be noted that no claim for hostel facility shall be made by any student or the parents/ guardians on any ground whatsoever.
